Also, present and acting: Mayor Bart Castleberry, City Clerk/Treasurer Michael O. Garrett, & City Attorney Chuck Clawson. **Alderman Pruitt was not present.***

**Ordinances Passed:**

- O-17-133 Ordinance vacating portions of the north-south alleyway in Block 6 and all of the north-south alleyway in Block 8 in the Burns Addition. **Vote 7-0**
- O-17-134 Ordinance approving the private club permit process for Red Robin – Conway Club, Inc. **Vote 7-0**
- O-17-135 Ordinance rezoning property located in the 1200 Block of Covington Way from I-3 to MF-3. **Vote 7-0**
- O-17-136 Ordinance amending the golf cart ordinance allowing for temporary approval of golf carts on city streets for commercial use with prior approval from the Office of the Mayor. **Vote 7-0**
