

ORDINANCE NO+ A- 414

AN ORDINANCE PROVIDING FOR THE SALE OF PARKING PERMITS WITHIN THE CITY OF ONWAY; PROVIDING FOR THE PAYMENT OF SAID PARKING PERMITS; DECLARING THE PURCHASE OF SAID PARKING PERMITS TO BE A PRIVILEGE; REGULATING THE PARKING OF VEHICLES DISPLAYING PARKING PERMITS; REPEALING ORDINANCE NO. A-277 PASSED JULY 8, 1952; AND FOR OTHER PURPOSES,

WHEREAS, the City of Conway, Arkansas, has heretofore authorized the sale and use of Parking Permits within said City and declared that the parking of motor vehicles displaying said Parking Permit to be a privilege by the adoption of Ordinance No, A-277, passed and adopted July 8, 1952; and

WHEREAS, the City Council feels that it will be to the best interest of the citizens of the City of Conway to impose certain regulations on the use of said Parking Permits;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. That Ordinance No, A-277, passed and approved July 8, 1952, is hereby repealed and made of no further force and effect,

SECTION 2, That the City of Conway hereby declares that it shall be a privilege for any person, firm or corporation to purchase and use a Parking Permit within the City of Conway.

SECTION 3, That, upon payment of the imposed charge for said Parking Permit, payable each calendar quarter, in advance, at the rate of \$5.00 monthly, such payment to be made to the Parking Meter Officer of the Conway Police Department, the purchaser of said Parking Permit shall be authorized to park the vehicle to which said Parking Permit is issued, in any designated metered parking space within the City of Conway without depositing money in said parking meter, Such parking, however, shall be subject to the following restrictions and regulations:

- (a) The vehicle must display a current, valid Parking Permit Sticker, such sticker to be displayed in the

lower left corner of, the rear window of said vehicle,

- (b) The vehicle must be parked in a metered parking space which has been designated for such parking by the Police Department, Any vehicle bearing a Parking Permit sticker which shall be parked in a metered space **not** designated for such parking shall be subject to the ordinances of this City regulating the depositing of coins into said parking meter and will, **if** found to be overparked, receive a Parking Ticket in the same manner as if no Parking Permit had been displayed,
- (c) The Police Department, from time to time, shall survey and designate the metered parking spaces which may be used for Permit parking and will cause such spaces to be clearly marked, by signs or color code, for such Permit parking, No space previously marked for Permit Parking may be changed to prohibit Permit parking except that immediately prior to beginning of any calendar quarter the Police Department may change any said space so **as** to prohibit Permit parking therein and in such event all purchasers of Parking Permits shall be properly notified of said change,
- (d) The restrictions and regulations imposed by this Ordinance shall become effective on July 1, 1964,

SECTION 4, All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 5. This ordinance, being necessary for the immediate preservation of the public health, peace and safety, **an** emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval,
