

ORDINANCE NO. A- 527

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF CONWAY, ARKANSAS: DECLARING SUCH TERRITORY TO BE A PART OF SAID CITY: DECLARING AN EMERGENCY: AND FOR OTHER PURPOSES.

WHEREAS, certain property owners lying adjacent to the city limits of Conway, Arkansas, did petition the County Court of Faulkner County, Arkansas for an order annexing the hereinafter described territory to said City; and

WHEREAS, after proceedings being had upon notice by publication, all as provided by and in accordance with the laws of the State of Arkansas, the judge of the County Court of Faulkner County, Arkansas, did, on September 15, 1971, enter his order of annexation to said City of the hereinafter described lands:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. That the City Council of Conway, Arkansas, does hereby accept the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on September 15, 1971, said territory being described as follows: to-wit:

All that part of the Northwest Quarter Southwest Quarter ($NW\frac{1}{4} SW\frac{1}{4}$) of Section 17, lying West of the Last right-of-way line of Interstate 40, and all that part of the South Half *Southwest Quarter ($S\frac{1}{2} SW\frac{1}{4}$) of Section 17, lying East of the West right-of-way line of U.S. Interstate 40, and a part of the Northeast Quarter Southeast Quarter ($NE\frac{1}{4} SE\frac{1}{4}$) of Section 18, and the Southeast Quarter Southeast Quarter ($SE\frac{1}{4} SE\frac{1}{4}$), Section 18, more particularly described as follows: Beginning at a point which is 832.6 feet North of the Southeast corner of said Northeast Quarter Southeast Quarter ($NE\frac{1}{4} SE\frac{1}{4}$) of Section 18, and run thence South $67^{\circ} 10'$ West a distance of 179 feet; thence South $29^{\circ} 4'$ West a distance of 301.4 feet; thence South $61^{\circ} 25'$ West a distance of 95 feet; thence South 110 feet; thence South $470\ 7'$ Last a distance of 98.2 feet; thence South $28^{\circ} 26'$ East a distance of 193.9 feet; thence South $48^{\circ} 17'$ East a distance of 106.1 feet; thence East to the East line of the Southeast Quarter Southeast Quarter ($SE\frac{1}{4} SE\frac{1}{4}$) of Section 18; thence North to the point of beginning all in Township 5 North, Range 13 West.

And that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2. It is ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; that this ordinance shall take effect and be in force from and after its passage and publication.
