

ORDINANCE NO. A-562

AN ORDINANCE ESTABLISHING SEWER
IMPROVEMENT DISTRICT NO. 6 OF CONWAY, ARKANSAS

WHEREAS, parties claiming to be more than a majority in value as shown by the last county assessment of the property located within the territory hereinafter described have filed a petition praying that an improvement district be established for the purpose hereinafter set out; and

WHEREAS, after due notice as required by law, the City Council of the City of Conway, Arkansas, has heard all parties desiring to be heard, and has ascertained that: said petition was signed by more than a majority in value, as shown by the last county assessment, of the owners of real property situated within the said territory:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. There is hereby established an improvement district embracing the following described property in the City of Conway, Arkansas:

Block 1, 2, 4, 5, N. F. Ward Subdivision of the City of Conway, Arkansas. Also that parcel of land described as follows: Beginning at a point 767.50 feet West and 977.00 feet North of the Southeast Corner of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) Section 13, Township 5 North, Range 14 West, run thence North 310 feet, run thence East 395 feet, run thence South 310 feet, run thence West 395 feet to point of beginning.

for the purpose of constructing necessary sanitary sewer facilities, including but not limited to, collection lines, mains, extensions, and related lines to connect the facilities to the sewer system of the City of Conway in order to serve the inhabitants of the District, all to be located and constructed in the places in and outside the District and in the manner and of the materials that the Commissioners for said District, to be hereinafter appointed, shall deem for the best interests of the District.

Said District shall be known as Sewer Improvement District No. 6 of Conway, Arkansas, and H. M. Gregory, N. F. Ward, and Robert Ott are hereby named Commissioners.

SECTION 2. This Ordinance shall take effect and be in force from and after its passage.




