

ORDINANCE NO. A- 576

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS: ASSIGNING AND INCORPORATING SUCH LANDS TO A WARD IN SAID CITY: DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the County Court of Faulkner County, Arkansas did, on the 16th day of January, 1974, enter its order annexing certain lands to the City of Conway, Arkansas; and

WHEREAS the City of Conway desires to accept such annexation and to attach and incorporate said lands to the proper ward of said City:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. The City of Conway, Arkansas hereby accepts the hereinafter described property, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on January 16th, 1974, said territory being situated in Faulkner County, Arkansas and described as follows, to-wit:

Part of the East Half (E 1/2) of the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of Section Thirteen (13), Township Five (5) North, Range Fourteen (14) West, described as beginning at a point Seven Hundred Eighty -five and five tenths (785.5) feet North of the Southwest corner of said East Half (E 1/2) Northeast Quarter (NE 1/4) Southwest Quarter (SW 1/4) and running thence East Five Hundred Eighty three (583) feet; thence North Two hundred fifty nine and five tenths (259.5) feet to the South Right-of-way line of Arkansas Highway No. 286; thence Northwestwardly along the South Right-of-way line of said highway, a distance of Six hundred twenty (620) feet to the West line of said East Half (E 1/2) Northeast Quarter (NE 1/4) Southwest Quarter (SW 1/4); thence South Four hundred sixty five (465) feet to the point of beginning, containing Five (5) acres, more or less.

and that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2. From and after this date the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits of said City.

SECTION 3. The hereinabove described lands are hereby attached to and incorporated within Ward One (1) of the said City of Conway.

SECTION 4. It is ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists, and that this ordinance shall take effect and be in force from and after its passage and publication.
