

ORDINANCE NO. 0-80-12

AN ORDINANCE FIXING THE RATES TO BE CHARGED FOR THE SERVICES OF THE CABLE TELEVISION SYSTEM AND DECLARING AN EMERGENCY.

WHEREAS, Paragraph 2 of Ordinance 0-79-22 states: "The rates charged for cable television service shall be set by the Conway Corporation subject to the approval of the City Council", and

WHEREAS, the rates attached hereto are recommended by the Conway Corporation as being adequate and appropriate to "provide adequate revenues to cover the costs of operation and maintenance, bond fund and other debt service requirements, plant expansion and necessary and reasonable surpluses and reserves."

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section One. That the terms and rates of the Cable Television System attached to and hereby made a part of this ordinance are herewith adopted as those to be in effect upon passage of this ordinance and thereafter until changed by ordinance.

Section Two. It is ascertained and declared that the implementation of the referenced rates is of immediate concern to the inhabitants of the City; that by reason thereof an emergency exists and this ordinance, being necessary for the immediate preservation of public welfare, shall take effect and be in force from and after its passage and publication.

Availability - At any point on the CTV distribution system within the corporate limits of the City of Conway.

Application - For service to individual customers premises - Service is for the use of the individual customer and may not be shared with others.

Payment - The net bill computed in accordance with the net monthly rate shall be due and payable upon presentation. If payment is not received within 30 days after presentation of bill, service will be discontinued. The delinquent bill plus a reconnect charge of \$15.00 must be paid before service will be restored.

RATE CTV 2

Cable Service Rate Schedule - Motels, Hotels - Bulk Rate

Availability - At any point on the CTV Distribution System within the corporate limits of the City of Conway.

Application - For service to guests rooms in motels and hotels. Service is for the use of guests of the motel or hotel and may not be shown in any halls, lobbies, lounges or similar common rooms.

Net Monthly Rate - Per Room - \$10.00

Payment - The net bill computed in accordance with the net monthly rate shall be due and payable upon presentation. If payment is not received within 30 days after presentation of bill, service will be discontinued. The delinquent bill plus a re-connect charge of \$15.00 must be paid before service will be restored.

Other Provisions - Conway Corporation CTV will be responsible for normal maintenance on converters and other items installed and owned by the Conway Corporation; however, property owner is responsible for theft or damages to Conway Corporation equipment installed on owner's premises and owner will reimburse the Conway Corporation for replacement or repairs to said equipment.

RATE CTV 3

Cable Service Rate Schedule - Institutional Bulk Rate

Availability - At any point on the CTV distribution system within the corporate limits of the City of Conway.

Application - For service to institutions with dormitory rooms. Service is for the use of residents of such dormitories. Dormitories shall be classified as units with more than 25 rooms.

Net Monthly Rate - Per Room \$7.50

Payment - The net bill computed in accordance with the net monthly rate shall be due and payable upon presentation. If payment is not received within 30 days after presentation of bill, service will be discontinued. The delinquent bill plus a reconnect charge of \$15.00 must be paid before service will be restored.

CONWAY CORPORATION CABLE TELEVISION SYSTEM

RATE CTV 4

CTS Service Charge Schedule

Installation Charge - New Service - First Outlet - \$25.00

Installation Charge - Each Additional Outlet - 12.50

The above installation charges cover installation in structures which have not been previously wired. Installation in previously wired structures will be charged at the rate of 50 percent of the above. All pre-wiring must be done in accordance with Conway Corporation Bulletin CTV 101.

Service Charge

\$15.00

This charge applicable for service call for modification of equipment, changing tiers of service, replacement or identifying of proms and other miscellaneous calls.

Payment

The applicable charges shall be due and payable upon application for service.
