ORDINANCE NO. 99-15

AN ORDINANCE ACCEPTING THE ANNEXATION OF
CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS;
DECLARING AN EMERGENCY;
AND FOR OTHER PURPOSES

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
CONWAY, ARKANSAS:

SECTION 1: The City of Conway, Arkansas, hereby
accepts the hereinafter described territory, annexed to
said City by order of the County Court of Faulkner County,
Arkansas, heretofore entered on the 26TH day of FEBRUARY,
1999, said territory being situated in Faulkiner County,
Arkansas and described as follows:

The North 1/2 SW 1/4, Section 16, 80 acres,
more or less; The North 1/2 NW 1/4 SE 1/4,
Section 16, 20 acres, more or less; The
North 1/2 SE 1/4, Section 17, 80 acres, more or
less; ALL in Township 5 North, Range 14 West,
containing in the aggregate 180 acres, more or
less,

and that said above-described lands and territory be,
and the same hereby are, declared to be a part; of the
City of Conway, Faulkner County, Arkansas, and shall
be aoned A-1.

SECTION 2: From and after this date, the inhabitants
residing within and upon the hereinabove described lands
and territory shall have and enjoy all the rights and
privileges of, and be subject to all the laws, rules,
ordinances, limitations, and regulations imposed upon the
inhabitants within the original limits of said City of

Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as a part of Ward 1 of the City of Conway, Arkansas.

SECTION 4: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; and that this ordinance shall take effect and be in force from and after its passage and publication.
